



**EXHIBIT B: PARKING GUIDELINES FOR MOBILE FOOD VENDORS**  
**University of Illinois at Urbana-Champaign**

Mobile Food Vendors may use only Designated Parking Spaces from the predetermined list, as determined by the University of Illinois Parking Department. The Illini Union Campus Vending Office may approve special event parking for locations outside of the Designated Parking Spaces. Mobile Food Vendors must follow all of the guidelines while parked on campus and adhere to the additional prohibitions below.

**Mobile Food Vendors may not:**

- Use any parking space without prior authorization from the University Parking Department unless paying at designated meters;
- Obstruct visibility of a pedestrian crosswalk;
- Encroach upon or obstruct bike lanes;
- Encroach upon or obstruct bus pick up/drop off locations;
- Be located directly in front of an existing business or storefront;
- Be located adjacent to a busy intersection and add to vehicle and pedestrian congestion;
- Contribute to any other traffic lane encroachment or visibility obstruction the University deems unsafe; or
- Use tents, tables, chairs or other forms of displays or signage in the designated vending areas.

The Parking Department will address bag meter requests on a first-come, first-served basis and may cancel meter bag agreements at any time. Mobile Food Vendors may choose to occupy non-reserved (unbagged) Designated Parking Spaces by paying University meters for the time they are there.

**Additional Parking Notes:**

- University meters are enforced 6 a.m. - 6 p.m., Monday-Friday. University meters are not enforced on Saturdays, Sundays or on official [Campus Holidays](#).
- For FY19, the fee to reserve two parking metered spaces on campus is \$40/day.
- Meters must be paid prior to the arrival of a parking service agent or a citation will be issued.
- Reservations made less than 24 hours in advance will incur a \$25 same-day bagged meter fee (per meter) and only if the requested location is available.
- Payment for reserving meters is due at the time of reservation and is non-refundable

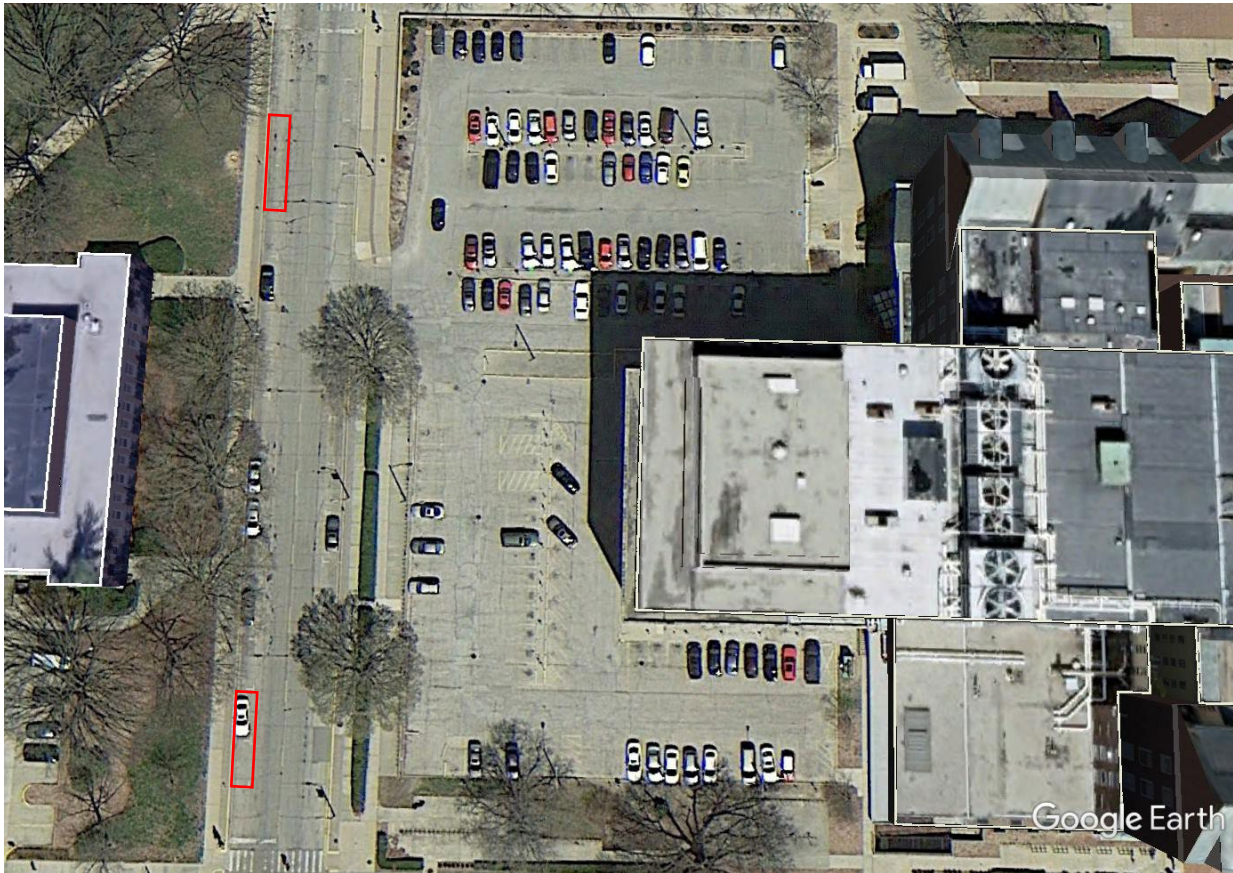

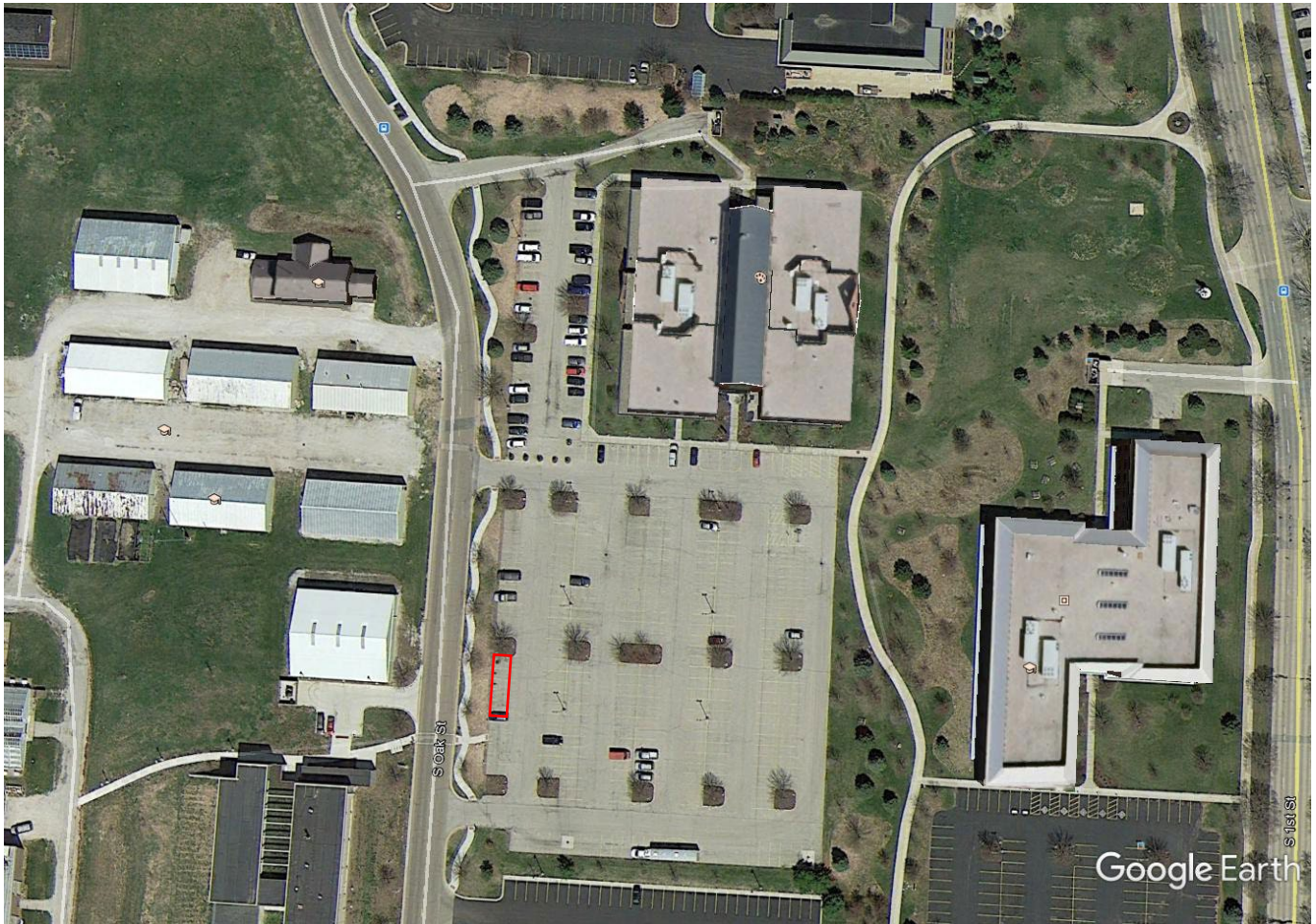
